As we agreed, this organization is being set up as a permanent body to champion all civil liberties, and it is expected that its first task will be to investigate and take action on the apparent encroachments upon civil rights found in the procedures attendant on the present investigation of leaks of secret information to the Soviet Union. Our research has been proceeding for some time. in the hands of a fact-finding committee appointed by our temporary organizing committee. We enclose a summary of its findings, which are available at length in a large report.

We feel that this summary might well be released to the press, and request your permission to release it as a fact-finding report submitted to the sponsors. Such a release would, we feel, give the organizational meeting considerable, publicity; and publicity is needed to overcome the serious apathy, toward the injustices in this procedure.

As this meeting is the result of nearly two months of hard work, with many discouraging delays, we earnestly request your full co-operation in making it a real success. We have planned brief newspaper advertisements, news and radio releases, street-car and window cards, and are using several m iling lists available to us for sending notices. We shall greatly appreciate any assistance you may be able to give us in this direction: by mentioning the meeting to your friends, by making available to us any lists of persons to whom we might send notices, and by contributing, if you can, to the expenses involved, which we estimate will total from \$200 to \$250. (The members of the organizational committee have met the preliminary expenses of the past two months by personal contributions.) The Public Affairs Council has contributed \$25.

We are preparing mimeographed applications for membership in the new organization, which we are calling, for the time being, the Civil Liberties Union, until it is decided whether it will be the Ottawa Branch of the Canadian Civil Liberties Union (Vancouver and Winnipeg Branches exist) or the Ottawa Civil Liberties Association. We enclose a copy of a draft constitution.

We would welcome an expression of your willingness to serve on the Council of the organization. The Council will elect an Executive Committee from its members.

As the meeting takes place on Wednesday next, we shall follow this letter with a phone call.
