WHEREAS the Land Claims of the Indian Bands of British Columbia is not settled;

THEREFORE BE IT RESOLVED that the Quatsino Indian Band Council demands that our Land Claims be settled before the patriation of the Canadian Constitution base on the framework of the Aboriginal Rights position of the British Columbia Indians.
