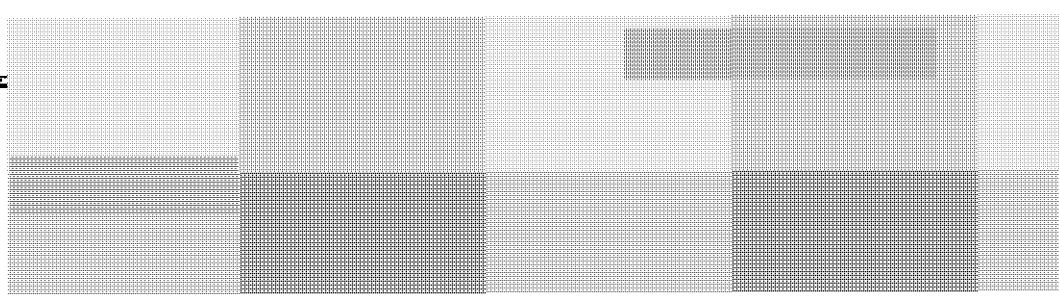

FURTHER TO OUR MESSAGES SS (OLY) 1134 DATED 30-4-75, S.S.(OLY)157 DATED 7-4-75 ON FILE [REDACTED] AND FOLLOWS DISCUSSIONS BETWEEN INSPECTORS BELL/VERMETTE AND C/SUPT COBB, OUR [REDACTED] SPECIAL AND [REDACTED] OPERATIONS WILL REQUIRE ADDITIONAL PERSONNEL ON A STAND-BY BASIS FROM OTHER DIVISIONS. DURING YOUR MAY 2ND VISIT TO MONTREAL YOU ARE VERBALLY BRIEFED ON THE NATURE OF THIS REQUEST. WOULD YOU PLEASE THEREFORE ADD THE ADDITIONAL REQUIREMENT DESCRIBED HEREUNDER TO OUR ORIGINAL DEMAND OF TELEX SS(OLY)157.

- THIS RESOURCE SHOULD BE AVAILABLE FROM 1 JUNE 1976 UNTIL 1 AUGUST 1976.
- PERSONNEL WOULD BE EXPECTED TO CARRY OUT THEIR NORMAL DUTIES (E.G. H.Q.) BUT BE AVAILABLE TO REPORT TO MONTREAL WITHIN UPON TWO FACTORS:
 - A) AVAILABILITY OF "C" DIVISION RESERVED INVESTIGATOR PERSONNEL NOT INVOLVED WITH OTHER OLYMPIC PRIORITIES, A SITUATION WHICH WILL FLUCTUATE.
 - B) NUMBER OF OPERATIONS REQUIRED
- A CO-ORDINATOR OF THIS RESERVE GROUP AT THEIR NORMAL WORK-SITE WOULD BE A NECESSITY.
- PERSONNEL SHOULD BE SELECTED FROM AMONG JUNIOR SECURITY SERVICE PERSONNEL AT CONSTABLE OR CORPORAL LEVEL.
- IT WOULD BE AN ADVANTAGE BUT NOT A NECESSITY TO HAVE ADDITIONAL LANGUAGE.
- PERSONNEL MUST RECEIVE A SHORT TRAINING COURSE WHICH SHOULD BE GIVEN BY HEADQUARTERS SECURITY SERVICE [REDACTED] OPERATIONS

- ON A HIGHLY INDIVIDUAL BASIS WE MAY REQUIRE THE SERVICES OF PERSONNEL OF OTHER DIVISIONS WITH SPECIALIZED LANGUAGE SKILLS NOT AVAILABLE LOCALLY.
- NEEDS CANNOT BE FULLY IDENTIFIED DUE TO UNFOLDING POLITICAL SITUATIONS PERHAPS YET UNFORESEEN. A CERTAIN AMOUNT OF FLEXIBILITY WILL BE NECESSARY.
- MANPOWER REQUIREMENT WOULD NOT BE SIGNIFICANT IN NUMBERS.
