1. PLEASE DESTROY COPY OF OUR LETTER DATED 26 JAN 76 THIS SUBJECT. AS A RESULT OF DISCUSSIONS WITH S/S/M [REDACTED] HQ ADMIN, THE FOLLOWING POINTS SHOULD BE ANSWERED ASAP IN ORDER TO PROCEED WITH THE NAMING OF HQ S.S. MEMBERS WHO WILL BE SECONDED TO "C" DIVISION FOR OLYMPIC DUTIES.

- (A) WHAT DUTIES WILL THESE MEMBERS BE PERFORMING IN "C" DIVISION DURING THE OLYMPICS? WHEN WILL THEY BE REQUIRED TO REPORT FOR THESE DUTIES?
- (B) WILL THESE DUTIES NECESSITATE TRAINING?
- (C) IF SO, WHAT TRAINING, LENGTH OF TRAINING AND WHEN AND WHERE WILL TRAINING TAKE PLACE?

A CONSIDERATION IN THIS REGARD IS THAT MEMBERS IN "HQ" HAVE BEEN REQUESTED TO USE UP ALL OUTSTANDING LEAVE CREDITS FOR THE 74/75 YEAR AND TO USE UP SOME OF THEIR LEAVE FOR THE 75/76 BEFORE THE 1ST OF JUNE.
