THE OFFICER I/C "A" DIVISION SECURITY SERVICE

Re: 1976 Summer Olympics
Security Service Planning
"A" Division

1. The foregoing is a follow-up to the initial planning report submitted on 23 Jun 75 on this file. The time frame of this report will include all activities up until 31 Dec 75. The same structure will be followed in order that continuity will remain.

(A) MANPOWER: A total of 75 positions have been identified within "A" Division Security Service to fulfill our needs. Eighteen functions have emerged which will require 65 R/M's, 11 S/Cst's, C/M's & C/R's. This does not include the two officers positions. An additional 30 R/M's have been identified and assigned to V.I.P. functions for short term duty.

An activity chart is appended which provides a detailed breakdown of the total resource package, but only a cursory outline of their duties. Their functions will be outlined in mini-job descriptions and provided to those concerned prior to 1 May 76.

(B) ACCOMMODATION: Unchanged in Kingston. However, through efforts made by Cpl. [REDACTED] we have been successful in acquiring two 3 bedroom cottages for "I" OPS needs. These are located at the Pinecrest Resort, 12 miles east of Kingston which will allow a 15 minute response time to the downtown area. A private line will be installed at one cottage to facilitate communications and a similar system will be placed at the Lucerna Hotel, Kingston, which was previously identified as being either a command post for "I" OPS [REDACTED]

(C) SURVEILLANCE: It is my understanding that a report from the OIC "C" Division S.S. to the D.D.G. (OPS) will negate the need for the 24 previously identified "I" OPS members to travel to Montreal for duty at that point. Instead they will be placed on stand-to in Ottawa, however, in discussions with Insp. VERMETTE it was stressed that the stand-to should be practical - i.e. 24 hrs response time. Whether or not the equipment - aircraft radios - etc. is still required is not known. The 24 members will be required to undergo orientation program in Montreal, presumably in April/May. The remaining "I" OPS road personnel will undertake similar familiarization procedures in Kingston during May '76 as this was unable to be done as proposed this past fall.

(D) S.S. OPS CENTRE

KINGSTON: To be manned 24 hrs a day. A minimum of three members available per shift. Will be located on the S.S. office and will include KW-7, dedicated lines to both Ottawa & Montreal S.S. OPS Centres, [REDACTED]

[REDACTED] Other existing Detachment phones will be available.

Should the need [REDACTED] emerge, it is strongly urged that the recovery, translation and assessment of the product be done in Kingston as opposed to routing it back to Ottawa to C-400. This is to be discussed with our "HQ" personnel in the immediate future as there may be some security problem which necessitates a flow back to Ottawa.

OTTAWA: To be located in R-719 where our existing OPS Centre is located. All communications facilities will be available. To be manned 24 hrs per day with a Sr. N.C.O. in-charge. There will be a pool of 11 investigators plus 10 members who will primarily be assigned to monitoring details in support of [REDACTED] The monitoring support group will be tasked with both Ottawa & Kingston or any other divisional area where the need may arise. The same is equally true for the members assigned to the investigator's pool.

(E) KW-7 - To be installed in the Security Service Office at Kingston Detachment.

(F) SECURITY SCREENING: No problems have been encountered and the process for Kingston is functioning very well.

To date no program has been set-up for the Ottawa area, but due to the relative small number (500) of screenings to be done no problems are anticipated.

(G) CONFLICT GAMES: A second game was held in Kingston during Sept '75 with emphasis placed on resources. A mini C.P. is tentatively slated for March 3, 1976 with a major C.P. Exercise taking place on 5, 6, 7 & 8 Apr 76.

(H) DEFUSING: An assessment of the Kingston groups who may cause Olympic problems is currently underway. All groups are being looked at in this analysis and as stated previously defusing is a means to neutralize certain groups but the major problem in Kingston is who remains within an organization once the University semester concludes. What may be classed as a threat now, could be defused by itself when students move for the summer.

"D" OPS analysis is an on-going affair and does not require special attention at this time.

(I) LIAISON: In addition to participation at the Chief Security Committee (Kingston Activities) meeting both Cpl. [redacted] and myself are members of the 6 member Sub/Committee on Intelligence. Composed [redacted] the function of this group is to provide an intelligence arm for the C.S.C. (K.A.).

(J) CO-OPERATION WITH C.I.B.: Unchanged - excellent rapport exists.

(K) CONFERENCES/MEETINGS: Unchanged - participation as required. Excellent method for exchanging ideas and developing programs.

(L) TRAINING: Contrary to our initial thinking no definite need has developed. As the majority of our members will perform Security Service functions, there is no need for further training. Those assigned to V.I.P. duty will receive the required lectures, but through C.I.B.

A program is being drafted to mesh with the [REDACTED] and will be approximately 50 minutes duration. [REDACTED] included are the R/D & C.O.I.L.S. program. This will be given to all Police Forces along the Seaway with the main theme being Refugee/Defectors.

Seven members (4 primary - 3 alternate) have been selected to attend a proposed V.T.R. course at "HQ".

(M) "A" DIVISION SECURITY SERVICE OLYMPIC COMMITTEE

Commencing on the 19 Jan 76, monthly meetings will be held with the purpose of providing progress reports on Olympic Planning. In addition the operational groups will have the opportunity to expand upon any investigation which is Olympic orientated.

(N) C.O.I.L.S.

In mid-Nov 75, S/Sgt. [REDACTED] of "HQ" "D" OPS and Sgt. [REDACTED] of our Olympic Secretariat provided an excellent briefing on this program to both C.I.B. & Security Service members. Our main area of response, as it applies to "A" Division "D" OPS, will be from Cornwall to Rockport. Kingston will handle that locale and as far east as the Thousand Island Bridge. The Sudbury member, of course has the largest area and one major crossing at Sault Ste. Marie.

(O) LINGUISTIC NEEDS:

Our requirements have been previously identified and strong efforts have been made to meet our objectives. In consort with Sgt. [REDACTED] of "D" OPS there remains only 2 dialects in which no promising leads have developed, those being Eritean & Pakistani.

(P) INVESTIGATIONS (THREAT) - "A" Div. "D" OPS have been involved in several investigations which could have a bearing on the security of the Games.

(Q) ASSESSMENT PROGRAM - (KINGSTON)

It is our intention to select one member, who has the necessary background and experience, coupled with several languages, whose sole purpose will be to circulate amongst the Olympic Village and Harbour. He will readily be identified as a Security Service member and can be used as a contact point, if required, by the athletes and support staff.

(R) SUMMATION:

Our involvement in the Ottawa scene has been complicated by the fact that no contract has been signed regarding Lansdowne Park. There has been an unanswered question over payment to the extra security personnel required, (C.O.J.O. or City's responsibility) but it is expected to be resolved in the near future.

No problems are expected in completing the programs mentioned, nor those currently being proposed. Although the primary goal for our involvement is the security of the XXI Olympiad through detailed planning, the secondary aspect is to expand on the role of the Security Service and both objectives are progressing favourably.
